## 1. Aims

This policy aims to:

- Set out our approach to requiring a uniform that is of reasonable cost and offers the best value for money for parents and carers
- Explain how we will avoid discrimination in line with our legal duties under the Equality Act 2010
- Clarify our expectations for School uniform.

## 2. Our School's legal duties under the Equality Act 2010

The Equality Act 2010 prohibits discrimination against an individual based on the protected characteristics, which include sex, race, religion or belief, and gender reassignment.

To avoid discrimination, our School will:

- Avoid listing uniform items based on sex, to give all pupils the opportunity to wear the uniform they feel most comfortable in or that most reflects their self-identified gender
- Make sure that our uniform expectations, and thus costs, are the same for all pupils within the school
- Allow all pupils to have long hair (though we reserve the right to ask for this to be tied back) and coloured hair (as deemed appropriate by the School).
- Allow an inclusive environment by adopting The Equality and Human Rights Commission's guidance on [preventing hair discrimination in schools](#).
- Allow pupils to request changes to swimwear for religious reasons. Schools will consider each request individually and make reasonable adjustments where possible. It will remain the School's decision to allow any change
- Allow pupils to wear headscarves and other religious or cultural symbols
- Allow for potential adaptations to our policy on the grounds of equality and protected characteristics by asking pupils or their parents to contact Mr Burpitt, who can answer questions about the policy and respond to any requests

## 3. Limiting the cost of School uniform

North Mead Primary Academy has a duty to make sure that the uniform we require is affordable, in line with statutory guidance from the Department for Education on the cost of School uniform.

We understand that items with distinctive characteristics (such as branded items, or items that must have a School logo or a unique fabric/colour/design) cannot be purchased from a wide range of retailers and may limit parents' ability to 'shop around' for a low price.

With this in mind, we will make sure that our uniform:

- Is available at a reasonable cost
- Limits the number of branded items required
- Provides the best value for money for parents/carers

We will do this by:

- Limiting any items with distinctive characteristics where possible: there is no expectation to where an item of uniform with the school logo.
- Not requiring pupils to purchase a branded school bookbag or particular style of coat
- Offering only one branded item- the Royal Blue sweatshirt available from the school office
- Avoiding different uniform requirements for different year/class/house group and for extracurricular activities
- Avoiding frequent changes to uniform specifications and minimising the financial impact on parents of any changes
- Ensuring that uniform supplier arrangements give the highest priority to cost and value for money (including the quality and durability of the garment).
- Making sure that arrangements are in place for parents to acquire second-hand uniform items
- Consulting with parents and pupils on any proposed significant changes to the uniform policy and carefully considering any complaints about the policy

## 4. Expectations for School uniform

### 4.1 Our School's uniform

#### School Uniform •

- Royal Blue Sweatshirt (either plain or with school logo- available from the school office)
- White shirt/blouse/polo t-shirt
- Black or Grey trousers/skirt/pinafore
- Blue/White Checked school dress
- Plain black shoes
- *Sweatshirts with the school logo are available to purchase from the school office, however plain sweatshirts are accepted.*

#### PE/Swimming Kit

- White t-shirt
- Black shorts
- Black jogging bottoms
- Black plimsolls
- Swimming costume/swimming trunks and towel

#### Seasonal Uniform changes

##### Summer

- Black or grey tailored shorts

##### Winter

- Royal Blue fleece (either plain or with school logo- available from the school office)
- Grey/Black tights

## **Jewellery**

We would encourage parents to avoid sending children into school wearing jewellery of any kind, as this can be a health and safety hazard. Jewellery should not be worn during PE/swimming lessons. Where jewellery is worn for religious purposes, parents can chat to us about our expectations.

- **Where to purchase it**
- **Our school uniform can be purchased from any high street retailer.**
- Sweatshirts with the school logo can be purchased from the school office but are not obligatory.
- Parents may also purchase a school bookbag from the school office.
- Information about second hand uniforms can be obtained by contacting our family support worker Mrs Hurst.

## **5. Expectations for our School community**

### **5.1 Pupils**

Our pupils wear the North Mead Primary Academy uniform with pride. The uniform is an important part of our School's identity and standing within our community. We ask that pupils always wear their uniform correctly including:

- On the School premises
- Travelling to and from School
- At out-of-School events or on trips that are organised by the School, or where they are representing North Mead Primary Academy (if required)

Pupils are also expected to contact Mr Burpitt if they want to request an amendment to the uniform policy in relation to their protected characteristics.

### **5.2 Parents and carers**

We ask that Parents and carers work in partnership with the School by ensuring that their child has the correct uniform and PE kit, and that every item is:

- Clean
- Clearly labelled with the child's name
- In good condition

Parents are also expected to contact Mr Burpitt they want to request an amendment to the uniform policy in relation to:

- Their child's protected characteristics
- The cost of the uniform

The School is committed to working with parents to resolve any concerns regarding School uniform. Parents are expected to lodge any complaints or objections relating to the School uniform in a timely and reasonable manner and the School will work closely with parents to arrive at a mutually acceptable outcome. Any disputes about the cost of uniform will be:

- Resolved locally

- Dealt with in accordance with our Trust's complaints policy

### **5.3 The School**

The School will ensure that the expectations for students/ pupils/ scholars/ pupil and for parents and carers are clearly communicated; the School uniform policy will be published on the School's website, and be made available for all parents, including parents of prospective pupils/students/scholars.

To support parents and families the School will: assess the overall cost implications of the uniform policy for parents and carers

- ensure that uniform supplier arrangements give the highest priority to cost and value for money (including the quality and durability of the garment).
- put in place arrangements for parents and carers to acquire second-hand uniform items

The School will work proactively with parents and pupils to ensure that uniform expectations are met. Where a pupil is not wearing the expected uniform, the School will put in place support to rectify this, for example through the loaning of uniform. Where accessing uniform is not a barrier and where appropriate, the School will apply the use of sanctions as outlined in the school behaviour policy.

## **6. Monitoring arrangements**

This policy will be reviewed every 2 years by our Schools Director. At every review, it will be approved by the Executive Team.
